In supersession of this Department's Notification No.A.12014/1/2021-FCS&CA dated 28.09.2021 and in terms of the provisos inserted in the principal rules vide the Mizoram Consumer Protection (Salary, allowances and conditions of service of President and Members of the State Commission and District Commission) (Amendment) Rules, 2021, the Governor of Mizoram is pleased to order creation of the following posts in the State Consumer Disputes Redressal Commission (State Commission) and the District Consumer Disputes Redressal Commissions (District Commissions) on 'Part-Time Basis' under the Consumer Protection Act, 2019 with immediate effect and until further orders:

At least one Member or the President of the State Commission and each District Commission shall be a woman as provided by Rule 3 (3) and Rule 4 (3) of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and Members of the State Commission and District Commission) Rules, 2020.

Consequent upon the above and with the concurrence of Finance Department, the rates of honoraria in respect of the 'part-time' Presidents and Members of the Consumer Commissions are fixed as below:

I. State Commission:

President, State Commission	The President of the State Commission shall be appointed on 'part-time basis' and shall receive a lumpsum remuneration of Rs. 1,39,500/- (Rupees One Lakh Thirty Nine Thousand Five Hundred) only per month along with a Consolidated Honorarium of Rs. 700/- (Rupees Seven Hundred) only per day of sitting.

II. District Commission:

	The President of the District Commission, if appointed on part-time basis, shall receive a fixed honorarium of Rs. 5,000.00 (Rupees Five Thousand) only per day of sitting. Provided that if the place of sitting is outside the headquarters of the President or Member of the District Commission, they shall be entitled to 'Travelling Allowance' and 'Daily Allowance' as per Rule 8 of the principal rules.
